Agreement:

As you will be collaborating with Dynatest A/S on your master's thesis, you accept the following terms concerning intellectual property rights and confidentiality with your signature.

You confirm that you are a student and working on a master's thesis in collaboration with Dynatest A/S. You are required to send valid documentation that proves that you are a student, and you must send the documentation to support@dynatest.com no later than 4 weeks prior to the start of your access period.

To work on your master's thesis in collaboration with Dynatest A/S it is required that you are given a free trial period of the Dynatest-owned software, Elmod6.

The Elmod6 must only be used for academic purposes and not for commercial use or any unlawful purpose or in any way that would violate any applicable laws or regulations.

Dynatest A/S reserves the right to terminate the collaboration with immediate effect if Dynatest A/S suspects that the documentation is not valid, and the student has misrepresented their student status.

Dynatest A/S requires receiving a copy of the final master's thesis. The final master's thesis is sent no later than two days after you have submitted it to the university.

When the thesis has been submitted, the collaboration ends, but the duty of confidentiality also applies after your collaboration with Dynatest A/S has ended.

When the collaboration ends the student agrees to immediately cease using the software, delete all copies of the software from the computer systems and all material belonging to the company must be returned. You may not exercise any retention rights in the material for any claim you may have against Dynatest A/S.

Dynatest A/S owns the right to inventions, know-how, improvements, copyright works, software, development of new systems and products, and the like, which you may create and/or develop as a result of or as part of your thesis collaboration at Dynatest A/S, regardless of which media these may be available.

You have a duty of confidentiality regarding everything that you experience in the performance of your work, about Dynatest A/S's circumstances, including matters relating to customers and business partners, etc., unless there are matters that should naturally be brought to the knowledge



of others.

You must ensure that all material relating to the affairs of Dynatest A/S is stored carefully and does not come to the attention of unauthorized persons.

The duty of confidentiality includes all material, including - but not limited to customer and price information, marketing material, know-how, software, strategies and concepts, technical drawings, recipes, and models in whatever form or media they may be available.

Any breach of professional secrecy will be considered a serious breach of the collaboration, which justifies dismissal. In addition, you are liable for damages for acts contrary to the duty of intellectual property rights and confidentiality.
